GSCA/Mason-Dixon Field Trial April 25 – 27, 2008

The GSCA/Mason-Dixon Field Trial Was held April 25 to 27, 2008 at the Norman G Wilder Wildlife Management Area at Petersburg, Delaware. Under the leadership of chairman Gwynne McDevitt, all possible eventualities are anticipated and planned in advance. In spite of her abiding attention to details the event got off to a stumbling start when Gwynne's red Dodge truck suddenly went dead on the side of Route 13 awaiting a tow truck with an apparent fuel pump malfunction. Fortunately, the trailer with the dogs and horses had already been dropped off at the grounds. Without the red truck to serve as a dog wagon, how would the dogs get to the starting line? Into the vacuum stepped Marianne Goodwin with her minivan, and the show went on without missing a beat.

Delaware weather for the trial followed the old East Coast adage that if you aren't happy with the weather, wait a minute and it will change. Friday was sunny and hot – too hot for some of the dogs, which resulted in handlers picking up dogs early to avoid heat fatigue. Saturday was cooler and dryer, whereas Sunday was much more favorable for dogs and people with low-hanging clouds, a good breeze, and just a hint of rain every now and then.

In her efforts to accommodate all entries, the three-day event was jam-packed and left no slack time, and none was needed. Gwynne had solicited helpers and assigned duties so that one stake would end and another would begin without delay. In addition to Marianne Goodwin and Steve Pacinelli, who ferried dogs back and forth and filled bird bags along with Lisa Miller, many thanks must go to Sandy Fisher who planted birds or marshaled during all three days. She got some relief from Jim D'Amico, Pat Sanborn, Ken Kohles and John Ward. Of course, field trial secretary Brenda Harvey was kept busy with paperwork and serving as scout for Gwynne who had dogs in most stakes. Much appreciation has to got to Jammie O'Donnell who volunteered to use his truck to tow Gwynne's horse trailer back to Pennsylvania on Sunday night.

The judges' dinner was held in the club house, which is undergoing some renovations and upgrading. Gwynne arranged to have the dinner catered by Jimmy's Grille, and a fine dinner it was with fried chicken, Virginia ham, chicken salad, boiled red potatoes, sweet potato pudding, lima beans and dumplings, followed with an outstanding assortment of delicious pies and cakes. Gwynne expressed her gratitude to the fine panel of judges including Jim and Kathy Kuhns, Greg Nickolson, Brian Maloney, Clint Sails, Debbie Freidus, and Lisa Miller who attentively evaluated the assorted performances. Breakfast and lunch were provided by Jim and Barbara. The Open Limited Gun Dog Stake on Friday brought out pro trainers with Jesse Chapman, accompanied by Dan Tenaglia, Jean Webb and Rob, and Jim Heckert, and numerous serious amateurs. It was won by Clint Sails' impressive vizsla.

Saturday began with the all Gordon Open Gun Dog Stake with 15 entries. Russ Chesina's Charger won the stake with a strong and mannerly performance. Second place went to Loch handled by Jesse Chapman and owned by Jane DeCasteja. Third was taken by Pat Sanborn's Strider handled by Jesse Chapman, with fourth going to littermate Rocky owned by Ken Kohles and handled by Jim Heckert.

Open Derby drew a field of twelve entries spread across six breeds.

The largest stake of the trial was Amateur Gun Dog with 15 braces. The stake began Saturday afternoon and completed Sunday morning. The judges had many strong performances to evaluate and selected Steve Hendrikson's classy English setter as the top dog.

Open Puppy drew a field of ten entries and exhibited some fine prospects for the future.

The final stake of the trial was Amateur Limited Gun Dog with eleven braces and 20 starters. Daylight was fast fading when the last brace was completed with the winning nod given to the pointer Tony's Redneck Bear.

Thanks again to Gwynne for her efforts to put on a tip-top trial with good judges, good food and good camaraderie.

President Larry Clifford called the meeting to order at 7:50 pm

Welcomed everyone to the banquet and commented on the good turn out.

A sheet for attendance was circulated and 34 members signed.

A quorum was certified.

Motion was made by Robin Marshall to accept the Minutes of the last meeting as published. Candice Bell seconded the motion and all voting members in attendance voted affirmatively.

Officers' Reports:

President: Larry Clifford-No report

Vice President: Laura Bedford-No report

Secretary: Cindy Fitzgerald-Just a reminder that AKC DNA numbers will now be required for all entrants at the 2008 GSCA National Specialty. Candice Bell has some kits available.

Treasurer: Nancy Smith – Balance in our general account is currently \$18,086 with the \$5,000 plus raised for Health and Genetics by the recent agility trial. That leaves a balance of \$12,241.95 with our club insurance of \$600 due and the dinner expenses for this evening to still pay out.

Committee Reports:

Agility: Maureen McLatchy – Reported that our February agility trial went great and that plans for the August 9 & 10, 2008 were coming along. Just a reminder that they will be indoors in New Hampshire, making it easier for our chair and committee.

Archives: Karen Gatchell- No report but a big thank you from the club to Jim and Joyce MacWalter for being TarTan's 'unofficial' photographers. Pictures are sent to the newsletter and to the website and then Jim burns a CD which we send to Archives. **Awards:** Coleen Banks-Forthcoming

Banquet: Laura Bedford – Great turnout, new room, TarTan gave new 'TarTan Rocks' magnets to each person here .

ByLaw Review & Revisions: Robin Marshall-Robin reported that we have received limited responses from the membership to our newsletter pleas and the committee has a meeting planned where we will insert all the suggestions and edits and then it will be presented to the Board for their comments.

'08 Spring Field Trial: Susan DeSilver reported that the dates will be April 12 & 13, 2008. Paperwork and judges have been approved by AKC but she is still in need for committee members and general help to run the trial successfully. The Fall field trial will be the last weekend in October.

'08 Spring Hunt Test: Ralph Schmid reported that the dates are April 26 & 27, 2008 in Hopkinton, NH and that things are moving along except they still need a few more judges.

Health & Genetics: Candice Bell reported that new updates are now on the website thanks to Lynn Tenny, especially a link to all the health clinics in the USA. She also wanted our members to know that TarTan will be hosting a booth at the 2008 GSCA National Specialty to collect DNA for the CHIC repository and asked that all TarTan members who might be in attendance volunteer to help out. Candice and the committee thanked Maureen McLatchy for donating over \$5,000 from the proceeds of the February agility trial to our AKC/CHF TarTan Gordon Setter Donor Advised Fund. This fund has allowed us to contribute to research for our Gordon Setters, currently helping to fund Dr. Dennis O'Brien's grant request for studies to locate a DNA marker for autosomal recessive, lethal, neurological disease in Gordon Setters. The CCA project has been fully funded but there are ongoing petitions for PRA and Juvenile renal dysplasia, although to date no researchers have signed on.

Inventory: Laura Bedford reported that she had inventory here and available which included our new 'TarTan Rocks' magnets. She is looking into flannel shorts and pants like we offered at the Sturbridge National.

Library: Phyllis Lundy reported that she had the tapes here and available for sign out.

Membership: Dorie Viguers -No new members.

Newsletter: Karol Paduch, Jeff and Jessica Martin, Ellen Shanahan- Karol just mentioned that the membership needs to continue to send information to the newsletter for publication. Everyone commented on what a good job Jeff is doing. Jani agreed with Karol to keep those stories, articles, jokes, recipes and book reviews coming.

According to the NAPCC, these 10 names top the list of plants that are poisonous to animals.

- 1. Marijuana All parts, whether dried or green.
- 2. Sago Palm All parts, but seeds contain the most toxin.
- 3. Lilies Should be avoided by all pet-friendly gardeners.
- 4. Tulips/Narcissus The bulb portion contains toxins.
- 5. Azalea/Rhodendron All parts.
- 6. Oleander All parts.
- 7. Castor Bean Seeds or "beans" are highly toxic.
- 8. Cyclamen Roots are more toxic than other parts.
- 9. Kalanchoe All parts.
- 10. Yew All parts.

In An Emergency

If your dog ingests a potentially poisonous substance, it's always better to be safe than sorry. Call your vet or the National Animal Poison Control Center (NAPCC), **888-426-4435**. Be prepared with as much information as possible about the toxin (plant name and description, label information, and so on) and have a credit card handy (a consultation fee may be charged). Always keep hydrogen peroxide or syrup of ipecac in your first-aid kit to induce vomiting if necessary.
