A few years ago a group of friends and myself took a wonderful trip to the Highlands to take in the Speyside distilleries, eat some fresh salmon, and visit the historical sites nearby. We were headquartered at a self-catering farm where the owners had refurbished the Steading (a Scottish term for farm buildings) into several apartments. Since there were six of us, we got the "Barn" which had its own entrance, a second floor deck overlooking the barley fields and Moray Forth, and a small rear garden where we grilled our fresh-caught salmon one day. From the farm we could venture east, west, north, and south to some of the most glorious spots in the Highlands. One day we trekked east to the town of Elgin, known for it's cathedral ruins. Snapping pictures

here and there, I suddenly came upon a piece of engraved stone. "Near this tablet in the tomb of their ancestors lie the remains of ALEXANDER DUKE OF GORDON who died in June 1827..." Wow! \_The\_ Duke of Gordon as far as our dogs are concerned! I snapped a photo and one of the area behind me showing the ruined facade of the old cathedral, burned in 1390 by the Wolf of Badenoch, Alexander Stewart, who was in a snit about being excommunicated.

We forced ourselves to visit just a few whisky distilleries, sampling the very fine Scotch along the way. One day we decided to drive to the northernmost point in Scotland, John O'Groats, but only





got as far as Wick before bad weather (a rarity is Scotland!) forced us to, instead, go shopping. Another day we visited the Culloden Battleground near Inverness where Bonnie Prince Charlie sacrificed over a thousand of his loyal Highlanders before running away, disguised as a woman. Then another day was spent at the most photographed site in Scotland, Eilean Donan Castle near Kyle of Lochalsh, where we picnicked and were buzzed by an RAF jet. On the way home we found a glorious meadow filled with blooming heather, just to top off a terrific day. Each night we took turns cooking a meal, mostly using local goods, had a few drams of fine whisky, and watched the sun set over the Forth. It was an idyllic way to see the north of Scotland and to get to meet the locals as well (pubs are great places to do that!).

#### **Acceptance of Minutes:**

Laura Bedford made a motion to accept the Minutes of the last meeting as published. Robin Marshall seconded and all present voted affirmative.

#### Officers' Reports:

**President:** Larry Clifford –no report except for rescue financial report which he gave to Secretary and various AKC event correspondence.

Vice President: Laura Bedford-No report at this time

**Secretary:** Cindy Fitzgerald reported limited correspondence;

Action Taken by the Board between meetings: Soliciting a Nominating Committee chairperson and instructing them on procedures

**Treasurer:** Nancy Smith reported a balance of \$14,148.17 after paying our club insurance of \$600 as well as sending \$7,522 to Health & Genetics (proceeds from the February agility trials).

#### **Committee Reports:**

**Agility:** Maureen McLatchy- no official report but Nancy had the financial reports from all three February trials which showed a total net gain of \$7,522 which is designated for the AKC/CHF TarTan GSC Donor Advised Fund.

Archives: Karen Gatchell —no report but Cindy mentioned that Karen was at the show to pick up some donations to archives from the Brates. She also mentioned that she had other members sending requested materials. Cindy had picked up a box of early TarTan records and Dot Whitney's breeding records from George Whitney and George also mentioned that he had a few hundred slides of old field trials that he would be contributing to Tartan. Cindy will pick them up from George in April. Laura Bedford made a motion that when we acquire these slides, we should have them professionally converted onto a CD. Robin Marshall seconded the motion and all members in attendance voted affirmatively.

**Awards:** Coleen Banks-no report however it was mentioned that Coleen felt that she had enough inventory for next year's awards as well. Everyone commented on what a great job she did this year and how good all the awards looked.

**Banquet:** Laura Bedford- reported that the banquet appeared to be a success as everyone had a great time. Jan Adams and her dog from Fidelco were interesting and the separate building was a lovely addition to the evening. Although we basically lost \$480, that was primarily because TarTan paid for a portion of all the members' dinners and it was discussed that it is a small price to pay back to our membership for all they do the rest of the year.

**By-Law Review and Revision:** Cindy is shooting to get the revised edition into the June newsletter for final membership comment prior to a membership vote.

'09 Spring Field Trial: Susan DeSilver- no report but trial secretary Larry Clifford said things are proceeding although the entries have been a little slower to come in than is usual. The date is April 11-12, 2009

'09 Spring Hunt Test: Ralph Schmid /Richard Dwyer-no report but the dates are April 24 & 25, 2009 in Hopkinton, NH Health & Genetics: Candice Bell-no report (mentioned in the Treasurer report)

**Inventory:** Laura Bedford-Reported that she has had verbal contact with a new supplier but nothing has been ordered and she is still entertaining new vendors. We suggested that she contact someone at Brandywine GSC as they have been very happy with their supplier.

**Library:** Phyllis Lundy – No Report.

**Membership:** Dorie Viguers did not send a report, however it was noted that the membership list has been printed in the newsletter and she had previously sent a 'Willing to serve' list to Cindy.

**Newsletter:** Jeff & Jessica Martin/Karol Paduch/ Jani Wolstenholem –HUGE positive response to all color newsletter from the membership. The Board agreed that a combined 2 month all color newsletter including the specialty would be a good thing to continue to promote. It was noted that Jani and Karol are working on promoting business card ads as well as full page ads to bring in some income.

**Picnic:** Robin Marshall reported that the picnic will be June 28, 2009 at the Flaherty Field Trial Area in East Windsor, CT. Robin propositioned a little something different this year per a suggestion by Jim MacWalter. **Rescue:** Ellen Shanahan reported no dogs currently in foster care but many inquiries for future dogs. She explained how the most recent rescue worked out. A dog was found in RI and had gone into a shelter in MA. The shelter contacted TarTan but addressed the dog's considerable medical issues themselves, also providing their own foster home. TarTan assisted them in finding a permanent home and also sent them a monetary donation for their efforts and to help offset their medical expenses for her.

(Note: rescue financial report was distributed after the meeting via email and approved by majority of board and will be published in the newsletter)

**Scholarship:** Richard Dwyer-no report but it was noted that the normal deadline for scholarship submissions was fast approaching and the scholarship information had not been advertised so Cindy Fitzgerald made a motion to extend the deadline for scholarship admissions, for this year only, to June 30<sup>th</sup>. Ellen Shanahan seconded and all members in attendance agreed with an affirmative vote. Laura will work with Richard to make sure that the necessary information is sent to both the Tidings and the GSCA newsletter.

'09 TarTan Specialty: Robin Marshall reported that Cathy Hill will be our secretary for this year's event. She is still pursuing a photographer. The judges are all set and her committee is in place. The AKC paperwork is being finalized and will be submitted shortly. Jani Wolstenholme had sent an inquiry to the Board asking about the possibility of opening up the obedience and rally portions of the specialty to all breeds in order to help defray the AKC costs. Discussion was that we felt it would be too confusing for the committee and secretary and that since the specialty and obedience are linked in the AKC paperwork, it would probably not be allowed. Previous discussion of tenting had resulted in the possibility of TarTan buying four EZ UP tents instead of renting tenting each year for the specialty. The tenting is a considerable expense (close to \$900) and if the club owned their own tents, they could be used for other events as well. The Board will ask Jim MacWalter if he would be willing to do some research on purchasing suitable EZ UP tenting. This led into a discussion of storage units for equipment which had also been previously discussed under new business at the last meeting. With the addition of this tenting, as well as our rings, obedience equipment and all other supplies, the board had decided to rent a self storage unit to house this equipment and will be looking into units in the South Windsor area in order to be close to the show grounds. The Board will ask Nancy Smith to make some calls to companies in the area and get prices.

**Supported Entries:** Karol Paduch had received an inquiry from Eastern Dog Club to host a supported entry at their show this coming December. The show has moved to Providence, RI. The Board will instruct Karol to look into adding Eastern Dog Club as an additional supported entry. Laura received a questionnaire packet from NESGA and will forward it to Karol. Cindy commented on how good the club has been to work with, the grooming area was large, the trophies were lovely and the club was helpful in acquiring a meeting room for us.

#### **FEATURED DOGGIE YUMMY!**

#### From Cooking the Three Dog Bakery Way Cupid's Crush Cookies

2 cups all-purpose flour
1 teaspoon baking powder
1/4 teaspoon ground cinnamon
1/4 teaspoon ground ginger
1/3 cup canola oil
1/2 cup molasses
2 tablespoons honey
1/4 cup unsweetened applesauce
5 large egg whites
2 teaspoons pure vanilla extract

Preheat oven to 350 F. Grease 2 baking sheets with nonstick vegetable spray.

Stir together the flour, baking powder, cinnamon, and ginger in a bowl and set aside. In a large bowl, stir together the oil, molasses, and honey until well mixed. Add the applesauce, egg whites, and vanilla to the molasses mixture and stir to blend. Add the dry ingredients and mix until smooth.

Drop the dough by the rounded teaspoonful, 1 1/2 inches apart, on the baking sheets. Using the back of a spoon, press down on each dough drop to make an indentation. Bake for 12 to 14 minutes, or until light golden.

Cool to room temperature before serving. Store in an airtight container for up to 1 week, or wrap well and freeze for up to 2 months.

In response to your request for input for the TarTan Tidings, I offer the following recipe. It is not for our four legged friends but for us humans, I do hope this is acceptable. This is my grandmother's recipe for Soda Scones. My granny was a bonnie wee lassie from Portadown, Northern Ireland. Although I attribute this recipe to her, my suspicions are that it goes back a bit further than that. These are not the scones you would have at an afternoon tea with clouted cream. No, these are far more substantial than that. When I was growing up, we would often have these as an evening meal on a Sunday. It was a real treat for us. I still continue the tradition with my kids and Grand-kids and they do seem to enjoy them as much as I did and still do. Enough said, so here ye go.

#### **SODA SCONES**

2 cups of flour 1/2 teaspoon salt 1/2 teaspoon cream of tartar 3/4 teaspoon baking soda buttermilk (approx. I cup)

Put all dry ingredients in a mixing bowl and mix thoroughly. Add buttermilk and mix into a soft dough. Turn out onto a well floured board and roll to 1/2 inch thick. Cut into any desired shape, square, triangle, round, etc., and place on a hot, lightly floured griddle and cook about 8 minutes on each side.

Griddle should be about 400 degrees F. Eat hot, lightly buttered or with fruit jam.

I normally triple this recipe as they do seem to be popular in my home and they are great the next day for breakfast. Hope you enjoy them as much as we have over the years.

p.s. My favorite jam with these is black current, but my family likes strawberry, pineapple and the wee bairns like them with grape jelly.

#### Ramblin' the Coverts

Picking up the thread of the last article, we come to the older dog. For whatever reason this poor soul has lived a sheltered life. Maybe Mom or Dad was led astray by the bright lights of the show world or they didn't really believe that their sweetheart would come back once off lead. But now we have the confidence to give the field thing a try. Great. Go back and read the article about training puppies. You're going to do much of the same kind of things. Yes the check cord is going to be a lot more heavy duty and you will want to put a nylon choke on the end of it. Both *L.L. Bean and Cabela's* sell ready-made check cords. Depending on the age of the dog, you may have to do quite a bit of bird work to get the juices flowing. Don't be discouraged if the dog you've been spoiling for the last two or three years doesn't just run right out and start hunting.

When you work an adult dog of any size, you want to wear leather gloves; cause rope burns are not a lot of fun. Also work the check cord like you are rappelling down a hill, one hand in front and the rope around behind to the other hand. A sixty-pound setter going full tilt after a bird is hard to stop, you need the added leverage of all your weight. Now you may find that the light of your life is not very interested, "I mean what the hey, I got liver treats for just standing around at the dog show, now you want me to work." It is not unusual for spoiled dogs to balk at the idea of fieldwork; you have to keep trying to fine what makes it click for them. I had an Irish that I worked with that would find every bird I put out and sit down next to them. One day I put a bird in a patch of multiflora rose, she couldn't sit next to it, so she pointed at it. And she pointed every bird she found from that day on. For the older dog that is just crazy for fieldwork, it is yard training on whoa, here and leave it, and lots of it. Dogs learn by repetition, doing it right the first time doesn't mean they do right the next time. You have to be getting it right most of the time before you move on to the next step. After a while you will be ready to take that baby step, letting your dog drag the check cord without you attached. You leave the cord on the dog for a while to be sure that you can catch him and reinforce the rules. I know that this sounds like a lot of boring work, but it will pay off in the end. A quick word on electronic collars, don't, it is not the easy way to shorten the training process and in the hands of a novice it is the route to screwing up your dog. If you have hit an impasse, spend some time with a trainer. It is no fun going out to hunt dog when you started out to hunt birds. And for those of you that want to do Hunting Tests, your brace mate is not going to be happy, if you're running an out of control dog that screws up the training they put into their dog. Take the time to do the training.

Now to discuss the two types of people that venture into the field with hunting dogs. Number one is the hunter; most are looking for a companion that is going to make the day a successful and enjoyable trip to the field. Good bird work is sometimes the greatest joy of the hunt, but most do not expect a fully trained performance. A dog that is steady to the flush and will hunt a downed bird is what the average hunter is looking for. On the other hand you have people that want to participate in Hunting Tests. For these people the rulebook and guidelines spell out exactly what is expected of you and your dog. Each level builds on the training you put into the level before, in the higher levels you will find that it is obedience to commands that you are training. The road to Master Hunter is a minefield that very few navigate. If you are lucky enough to own a Master and your other half tells you "It's me or the dog" be nice enough to help them pack.

A word or two on introducing the dog to the gun, don't take the dog out to local range or fire off a couple of blanks in the yard. The gun is best related to a happy time, like chasing a bird across a field. Only fire when he is in full pursuit, about 15 yards out. He probably won't even notice and if he does it should be "Good boy, lets find another."

The last two articles have only scratched at the surface of training hunting dogs, if you chose to go down this road, you will find many issues that are unique to your dog. You may have to work with someone with more experience. A fresh eye on a problem, at times, is all it takes. Until next time, when we talk about what we hunt with besides our dog.
