The winter TarTan Agility trials were held on February 6 and 7 and February 14 at American K9 Country in



NANNER'S INFLUENCE by Val Schmid

I was very fortunate to have had two wonderful grandmothers who had a profound influence on my life. So it stands to reason that when I became a grandmother 8 years ago, I was determined to have the same influence on my granddaughter, Reagan.

I am happy to report that I have been quite successful so far in being a positive part of her life – especially in fostering a love of animals in her!

It all started with my Maysie – who was just a pup when Reagan was born. Maysie was so disappointed about being adopted by two AARP eligible, empty nesters that the first time baby Reagan visited us she thought she had been presented with the best dog toy ever – a small child. Maysie to this day, never leaves Reagan's side when she visits and Reagan grew up fearless of play biting, dog drool, jump up and having her sandwich grabbed out of her hand.

When Reagan was two, I got Bozman (my long-haired, mini dachshund) and Reagan fell in love. Bozman became the only one that could get her to go to bed, stop crying, or eat her dinner. I foolishly promised her a dachshund just like Boz when she was seven. She never forgot that promise – not for one second. So when she turned seven in October, 2008, I had the pleasure of traveling to Atlanta and being with her parents when we presented her with an 8 week old puppy "just like Bozman". His name is Flash and Reagan and Flash are inseparable. I am so proud of Reagan because she is the ultimate dog-mommy. She takes excellent care of Flash and is as enthusiastic and in love with him as she was the day she got him.

Last Christmas Reagan really proved her love for dogs, though. It started as a bad idea of mine – a Christmas fund raiser to give dogs in shelters some Christmas presents. I was the author of the company newsletter so was often the originator of contests campaigns and causes. I had done my research and found out that the only things dogs in shelters are allowed to have are KONGS (just the big heavy duty ones) and blankets for their beds (in the dimensions of 25"x40" to go on their sturdy, off -floor Kuranda beds. That's it. No other toys or paraphernalia are allowed. They also accept dog biscuits and peanut butter to put in the KONGS and they love to get glucosamine- chondroitin since some of the older dogs need it and it is unaffordable. If you are really generous you can donate a Kuranda bed at about \$60 each.

To make a long story short, my company was less than enthusiastic about this endeavor and I got a few donations of KONGS and biscuits, some cash, and no old blankets.

Reagan decided we should just do it ourselves so we did. We shopped in bulk for KONGS in addition to donating Maysie and Shadice's. We collected old blankets and bought fleecy remnants at fabric stores. We got biscuits and peanut butter at Sam's Club and generic glucosamine at a discount pharmacy. Reagan cut blanket after blanket to measure the required 25"x40" on my living room floor and then held each one up to the wood stove to warm it before hugging it for a few minutes to fill it with love. That evening we packed up all our goods in baskets and drove to the New Haven shelter we had chosen. We had reached our goal – we had a KONG and a blanket for every dog that was in this shelter in addition to lots of biscuits and peanut butter.

The shelter stayed open late for us and was very appreciative of the gifts. Reagan was able to go in back and meet all the dogs and was able to take one bull dog out and play with it. She also saw and held some new puppies that were just born – after they took the mom to another part of the building! What a great time we had and what a wonderful experience for both of us. The shelter made us sad but the good news was that it was clean and warm and the dogs were well cared for and now they all had a clean blanket and a KONG. It was also good to see that many had a sign on their kennel saying they were taken, probably being picked up to be a Christmas present.



The hardest part was getting Reagan to leave the puppies behind. We think we might try this again next Christmas.

DOGGIE YUMMY of the MONTH!

HOMEMADE CHICKEN STOCK From Cooking The Three Dog Bakery Way

(This is doggie chicken stock to supplement or help your dog eat if they've been sick)

- 3 ½ pound whole chicken
- 2 to 3 carrots, peeled and trimmed
- 1 teaspoon ground thyme
- 1 teaspoon dried rosemary

Place the chicken in 4 quarts of water in a large stockpot. Bring to a boil. Add the carrots, thyme, and rosemary. Gently simmer for 1 hour, skimming excess fat off the top, until the chicken is cooked through.

Remove the chicken from the stock. Carefully separate the chicken meat from the skin and bones, and set aside. Reserve the stock and discard the skin and bones. Remove the carrots, place them in a small bowl, mash them with a fork, set aside.

You can use canned chicken stock, but the homemade kind has less additives:

12 cups Homemade Chicken Stock 1 cup long-grain rice Cooked and mashed carrots 2 cups cooked and shredded chicken

Bring the chicken stock to a boil in a large stockpot. Add the rice and carrots. Boil for 20 minutes or until the rice is tender. Remove from the heat and add the chicken. Cool to room temperature before serving. Store covered in the fridge for up to 3 days.
