### **Legislative Liaison Report**

A tenfold increase in the last ten years in the number of regressive dog laws across the nation has state federations reeling from organized legislative campaigns of over 1,100 bills at the federal, state and local levels. The AKC Government Relations Department is bringing together delegates from most of the 50 state federations for an inaugural conference on canine legislation on August 27-28, 2011 in Raleigh, North Carolina. I'll be attending this conference and will report on it next month.

Tartan Gordon Setter Club members are fortunate to have active and effective state federations reaching out to legislators on their behalf in all of our territory—with one exception—Rhode Island. Lawmakers in Providence saw dangerous bills this year in HB 5690 and SB 140. AKC Government Relations warned the bill "would, among other provisions make it illegal to allow your dog to play in a fenced-in backyard for more than one hour without providing an outdoor shelter. It also allows the local SPCA to enter private property without notice or a warrant to examine dogs and enforce the new law." This legislation saw no movement in Providence, but it remains alive and will remain on the calendar for next session.

Lawmakers in Boston saw a bill this year that AKC Government Relations declared in a legislative alert: "A Massachusetts legislative committee is scheduled to consider House Bill 1023 on July 19 - a bill that would significantly change the definition of kennel to encompass training facilities or any dog event with more than 12 dogs. All those meeting the new criteria would be required to comply with all state and local licensing and other regulations currently reserved just for large kennels.

"This would mean that any daytime activity where more than twelve dogs are present (including dog shows, training facilities, companion events, etc.) would now be considered a kennel and required to comply with all state and local kennel licensing and regulations."

By reaching out to the bill's sponsor, the Massachusetts federation was able to educate him about the bill's potential negative impact and the bill is being rewritten.

Connecticut, Massachusetts, Maine, New Hampshire, New York and Vermont have organized federations with websites and posted reports detailing their legislative efforts this year. To try to summarize all of the bills in one report would fill more pages than this newsletter contains. For example, Maine faced 19 bills and New Hampshire faced 20 bills this year. For a listing of all state federations, their websites, their legislative reports, and their contact information, please go to the AKC's website and click on "Government Relations".

At the federal level, US Senate Bill S 3424, called the Puppy Uniform Protection and Safety Act (PUPS), and filed by Senator Richard Durbin of Illinois, remains a concern from last year. The AKC "is currently studying the impact of this measure" but the Illinois Federation has issued a detailed analysis in opposition to this proposed law on their website.



Regular membership is open to all persons eighteen years of age or older, who are in good standing with the American Kennel Club and reside in the New England States and environs. Environs shall be defined as that part of New York State East of the Hudson River from New York City excluding Long Island to and including the City of Albany and east of the Northway (Interstate 87) to the Canadian Border. Each Regular member may vote and hold office and shall enjoy all the rights and privileges of the club.

Supporting membership is open to all persons eighteen years of age or older, who are in good standing with the American Kennel Club and reside outside of the New England States and environs as defined in section 1(a) of this article. Supporting members shall not vote, hold office or receive annual

awards, but shall enjoy all other rights and privileges of the Club.

Junior membership is open to all persons from 10 up to 18 years of age. Junior members shall not be entitled to vote or hold office, but shall enjoy all other privileges of membership. Only those Junior members who reside in the New England States and environs as defined in section 1(a) of this article shall be eligible for annual awards. Upon reaching the age of 18 years, Junior membership may be converted to regular or supporting membership without reapplication.

DUES- Yearly membership dues shall be \$20.00 for single membership and \$25.00 for more than one person residing in a household, payable before the first day of July each year. No member may vote whose dues are not paid for the current year. Each member will be sent each issue of the TarTan

Tidings, and all members are entitled to attend all Club meetings and functions.

July 27, 1929 – June 12, 2011



He was often by her side, joking, ribbing her Gordon friends, but always adoring her. If we were lucky, we got to ride in his chocolate-brown Jaguar.

It turns out, he was a weighty player in the financial community, credited with making the decisions that ultimately created bar-coding, as we know it now. That he had foresight, was obvious. That he had loyalty, was clear.

Natalie and Alan got their first Gordon, registered name: Ch. Mandy. That was it. Natalie's next dog was Sam. All the dogs after were Sam's sons. Plain and simple. She got involved in Gordons, and Alan was there, supporting her all the way.
